

Terms and Conditions for Exhibition Visitor Registrations

The attendance of each free of charge exhibition visitor ("Visitor") at the Event run by BME Events is subject to the following terms and conditions. Any refusal to act in accordance with these terms and conditions may lead to your removal from the Event.

By submitting your registration you agree to be bound by these terms. If you do not agree to be bound by these terms, BME Events will be unable to accept your registration.

1) The Event is open strictly for trade and business professionals only. As proof of status, a business card may be required. Minors under 18 years of age will not be admitted, including children of exhibitors and visitors. All attendees to the event must be in proper business attire. BME Events reserves the right without liability to refuse admission to, or to eject from the Event, any person in its absolute discretion, including (without limitation) any person who fails to comply with these terms and conditions or who in the opinion of BME Events. represents a security risk, nuisance or annoyance to the running of the Event. You agree to comply with all reasonable instructions issued by BME Events or the venue owners at the Event. BME Events reserves the right to cancel any visitor registration after confirmation without liability.

2) Each Visitor shall not:

- 2.1. Attempt to transfer his/ hers registration for the Event to another person, each registration is for personal use only.
- 2.2. Cause a nuisance to exhibitors of the Event ("Exhibitors"), BME Events (or its employees or representatives) or to occupants of any premises adjoining the Premises;
- 2.3. Engage in any form of disruptive or anti social behaviour whilst on or around the Premises;
- 2.4. Sell, provide or offer in any manner, any food, drinks (both alcoholic and non alcoholic drinks), cigarettes, any other tobacco or any other consumable of any nature whatsoever, unless the same has been permitted by BME Events.

- 2.9. Bring, or permit any animals to be brought, onto the Premises unless such animals are guide dogs or animals providing equivalent assistance;

5) All unauthorised photography and the recording or transmitting of audio or visual material, data or information is expressly prohibited. BME Events reserves the right to photograph, and /or to record the voice and image of the visitors, exhibitors, stands and any events or objects during the Event, and to use any such recording or photography for informational, promotional, marketing and other purposes.

6) BME Events reserves the right to postpone or cancel an Event, change format, content or any other aspect of the Event without liability at any time for any reason whether or not due to causes beyond its reasonable control. Where an Event is postponed, your registration will be valid for the postponed Event.
